


### water system

The Mantuan countryside is rich in spontaneous **water canals**, caused by the **flat and waterproof soil**, subjected to **floods**. Various **drainage works** have been done in order to organize waters, aiming to the maximization of the agricultural productivity. The landscape of this area of the Pianura Padana have always been characterized by **canals and artificial watercourses**, often sided by **cycle paths or tree rows**.



### woods and cultivated areas

The open flat land is alterned to **woods** and "alberate" (**tree rows**). The landscape is characterized by **big open spaces**, mostly occupied by **cereal cultivations, woods or orchards**. Thus, the prevalent **horizontality** of the flat land is **softened** by the **presence of vertical elements**, less big but still much relevant in this kind of context.
